

# How to nominate PKF as your authorised tax agent



## ATO CHANGES TO PREVENT UNAUTHORISED ACCESS TO CLIENT ACCOUNTS

### WHAT HAS CHANGED?


The ATO are implementing these changes to strengthen the security of your online services. This is to ensure that only the correct registered agents have access to your Tax and Super details.

This means that you now need to use the Agent Nominations feature to nominate PKF as your authorised agent, via [Online Services](https://onlineservices.ato.gov.au/business/) ([onlineservices.ato.gov.au/business/](https://onlineservices.ato.gov.au/business/)).

### HOW TO NOMINATE PKF

**1** Log in to your [Online Services](https://onlineservices.ato.gov.au/business/) business portal  
(See below if you do not have access to Online Services – you will need a MyGovID)

**2** Select Profile then Agent details



**3** At the Agent nominations feature

**4** Select Add

- 5** Type in your registered agent's number

  - c) 26008312 or type PKF (NS) SUPER PTY LTD

  - f) 64542008 or type PKF PORT STEPHENS PTY LTD
  - g) 25563821 or type ROSE & PARTNERS (PKF UPPER HUNTER)

**6** Select search

**7** Select the tax agent from the list

**8** Tick the declaration

**10** Email your PKF Representative to let them know you have completed the process.


